### Directions to Race Site:

If coming from the South on Highway 131, take exit #168 onto 20 Mile Road and go across the overpass to the West. Take a Right turn onto 200th Avenue (Yoder's of Tustin is on this corner). Stay on this road until it intersects with M55. Take a Left onto M55. Stay on M55 (about 6 miles) until you reach Galvanek's used cars and turn Right onto S 21 Road. Stay on S 21 Road until you reach W 38 Road, turn Left onto W 38 Road and stay on that road until you reach S 15 1/2 Road. Turn Right onto S 15 1/2 Road to the Lost Pines Lodge

If coming from the North on Highway 131, get off of the 1<sup>st</sup> Cadillac exit or Boon Rd. Go right towards Boon stay on this road and cross 115 to the end. You will go across a set of RR tracks and come to a stop sign. This is 23<sup>rd</sup> rd, go left or south. Go 2 miles to 38 Rd, go right 1 mile until a sharp curve to the left. Veer off to the right at this curve so you go onto a seasonal dirt rd. Still 38 rd and continue about 2 1/2 miles to Lost Pine Lodge on the corner on 38 Rd and 15 1/2 Rd.

## ISDRA DRIVER'S RELEASE AGREEMENT

I (print name) \_\_\_\_\_, hereby apply to participate in the Lost Pines Lodge Dryland, organized by the Great Lakes Sled Dog Association and sanctioned by the International Sled Dog Racing Association, Inc.

I acknowledge that there are risks of injury to persons or possible damage to equipment while participating in a sled dog race. I further acknowledge that I am participating in this race at my own risk. I understand that Great Lakes Sled Dog Association and ISDRA are corporations formed to advance the sport of sled dog racing, and that their efforts directly benefit me.

In consideration of my being permitted to participate in this race, on behalf of myself, my heirs, assigns and personal representatives, I hereby waive, release and forever discharge Great Lakes Sled Dog Association, ISDRA, any organizations or individuals involved in organizing and/or sponsoring this race, any municipalities or other public entities, and all of their employees, agents, officers, directors, attorneys, members, sponsors, promoters and affiliates whatsoever from any and all liability, claim, loss, cost or expense for personal injury, death or property damage arising from or attributable in any way to any action or omission to act of any such person or organization in the sanctioning, organizing or execution of this sled dog event, or my participation therein, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above, including but not limited to travel to or from or parking at the sled dog event.

Knowing the above risks of sled dog racing, I nevertheless hereby agree to assume those risks and to release, discharge and hold harmless all of the persons or entities mentioned above who (through negligence, carelessness or otherwise) might be liable to me or my heirs or assigns, for any and all damages for death, personal injury or property damage of any kind. The risks which I assume are all of those involved in participation in a sled dog event, including, but not limited to, those relating to trail conditions, weather conditions, passing of teams, contact between dogs and mushers on different teams or the same team, starting and finishing the race, sanctioning and officiating the race, spectator presence at the race, announcing and timing of the race, travel to and from and parking at the race, and all other natural and manmade conditions of any kind whatsoever pertaining to or occurring at this event.
